Re: Letter of Assurance, Glencore Copper Canada Assets

This letter is to attest that Glencore Copper Canada has a process in place to verify the information provided to the Mining Associated of Canada (MAC) with respect to our Towards Sustainable Mining (TSM) Performance Indicators.

On December 2nd, 2020 and April 22nd, 2021, Glencore Copper Canada's Assets, Canadian Copper Refinery (CCR) and the Horne Smelter, completed an independent third party verification of their 2019 TSM self-assessment results.
